I UNDERSTAND THAT ACCORDING TO THE ASSOCIATION'S CC&R'S, SECTION 10.2, ANY VIOLATING OF THE ASSOCIATION POOL RULES BY ANY MEMBER OF MY HOUSEHOLD OR BY ANY GUESTS OF A MEMBER OF MY HOUSEHOLD, OR ANY OTHER INVITEE OF MY RESIDENT MAY RESULT IN THE SUSPENSION OF THE USE OF THE SWIMMING POOL FACILITIES FOR ALL MEMBERS OF MY HOUSEHOLD, OR A FINE, OR BOTH. I ALSO AGREE THAT REPLACEMENT KEYS WILL BE ISSUED ONLY AFTER PAYMENT OF A KEY REPLACEMENT FEE OF \$25.00 HAS BEEN MADE TO THE ASSOCIATION, AND THAT REPLACEMENT CARDS WILL BE ISSUED ONLY AFTER PAYMENT OF THE REPLACEMENT FEE OF \$25.00 HAS BEEN MADE TO THE ASSOCIATION.
